- Member must be in good standing with the Cooperative.
- Submit within 90 days of purchase.
- Limit of two (2) rebates per member location.
- The charging station must be new and UL listed.
- The cooperative reserves the right to complete an on-site inspection of the charger after installation.
- The unit must be installed where electricity is supplied by the cooperative.
- The structure in which the member resides must be a permanent structure on a permanent foundation on the land owned by the member.
- Rebates are limited to eligible services (homes, lake homes, shops, barns, etc.) that purchase more than 6,000 kilowatt-hours of electricity from the cooperative on an annual basis.
- Rebates may be subject to load control programs. The participant agrees to allow the cooperative to control the timing of their charging now or in the future.
- Please allow 6-8 weeks for processing.
- Please keep a copy for your records.
- Please complete a separate application for each installation site.
